The Republic of Cameroon is located in Central Africa and shares its borders with the Central African Republic, the Republic of Chad, the Republic of the Congo, the Republic of Equatorial Guinea, the Republic of Gabon and the Federal Republic of Nigeria with surface area of about 475,442 km<sup>2</sup> and a population of approximately 29 million. The capital city is Yaounde.

The mining sector is regulated by Law No. 2023/014 of 19 December 2023 instituting the Mining Code and, in terms of

governance, Cameroon is a member of the Extractive Industries Transparency Initiative (EITI) and the Kimberley Process.

Our country has a rich and diversified mining potential thanks to a particularly favourable geological context, marked by the presence of various geological formations that are the result of several successive orogeny that have led to remobilization events conducive to the concentration of mineral substances such as Iron ore, Bauxite, Cassiterite, Gold, Rutile/Ilmenite, Nickel, Cobalt, Manganese, PGE, Sapphire, REE, Copper, Lithium, Uranium, Diamond, Limestone, Marble, Pozzolan, Disthene, Lignite and Oil shale. Amongst the projects mentioned above, we currently have three (03) iron ore mining projects which have actually started. These include: the Mbalam Iron ore, the Lobe-Kribi Iron ore and the Akom II (Grand-Zambi) Iron ore. In addition to the iron ore mining projects, we also have a gold mining project that has equally started.

The Mbalam project envisages an annual production of ten (10) million tonnes of DSO (66% Fe) in the first few years, before reaching an annual peak of thirty-five (35) million tonnes. The first export of DSO is

planned for 2024.

The Lobe-Kribi project envisages an annual production of 10 million tonnes of 33% iron ore, enriched to 4 million tonnes of 65% iron concentrate. The first export of iron concentrate will take place in 2025.

The Akom II project envisages an annual production of 6 million tonnes of 30% iron ore, followed by beneficiation to produce 2 million tonnes of 65% iron concentrate. The first export of iron concentrate will take place in 2025.
